EVENT HOST

Madeline is a 2024 Trailblazer Fellow who will utilize her grant to attend a youth leadership conference in Washington, DC over the summer and begin touring colleges with plans to study political science.

She founded the Winter Color Guard Program at Cotter High School, is captain of the Color Guard team, an active member of the Mock Trial team, and a National Honor Society member.

MADELINE SHARED:

"I remember in second grade doing an activity where we had to draw what we wanted to be when we were older. I drew an American flag with a podium and microphone in front of it. I had no idea what to call this job so above the flag I wrote 'Change.' All I knew was that someday I wanted to change the world."





ART OF DANCE

ENTERTAINMENT

Art of Dance, located in Brooklyn Park, is a dynamic dance studio renowned for its commitment to artistic excellence and community engagement. Owner Linda Green received a 2020 Impact Award from the Ann Bancroft Foundation for her work to empower students of all ages and skill levels to discover their rhythm, express themselves, and unleash their full potential on the dance floor. To date, over 20 talented Art of Dance students have received grants from the Ann Bancroft Foundation. Tonight's dance team includes Justine (2014 Fall Grantee), Justice (2014 Fall Grantee), Lynaya (2016 Fall Grantee), and Nyri (2023 Fall Grantee).





ETHELIND B. KABA

EXECUTIVE DIRECTOR

Ethelind is passionate about many things and wears many hats with one purpose: to spark in others the same curiosity about advancing human equity, potential, and dignity that motivates her work and life.

As the Executive Director of the Ann Bancroft Foundation since 2021, Ethelind champions its vision—a world in which all who identify as a girl have a chance to live their dream and reach their full potential. Ethelind also previously founded The Stargirl Initiative, a nonprofit dedicated to empowering teen and tween girls, for which she was named a Changemaker by *MN Women's Press*. She has also received recognition by Twin Cities Business as one of the "100 Top People of 2024," and by Minneapolis/St. Paul Business Journal as one of "50 Black Leaders To Know." Ethelind offers her experience and talents to several organizations including The Jeremiah Program as a Board Member and serves on the Board of Regents at Augsburg University.

"In a world where dreams are as diverse as the stars in the sky, I've had a million and one of them—from running a modeling agency to leading the human rights division at the UN. But what's truly remarkable is that my village has dreamed even bigger for me. And for that, I'll forever be thankful."



ANN BANCROFT

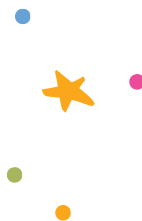
FOUNDER

Ann is one of the world's preeminent polar explorers and an internationally recognized leader who is dedicated to inspiring women and girls around the world to unleash the power of their dreams. At the age of eight, Ann's first expedition was in the backyard orchard during a subzero degree Minnesota winter. Many adventures later, further from home, she actualized her girlhood dreams of reaching the ends of the earth.

Ann's polar exploits created opportunities off the ice caps. In 2016, President Obama invited her to address scientists and educators from 25 nations for a unified response to climate change. Ann was one of Glamour Magazine's "Women of the Year" (2001), inducted into the National Women's Hall of Fame (1995), named Ms. Magazine's "Woman of the Year" (1987), and is honored in the Minnesota Historical Society's permanent exhibit, "MN-150" honoring 150 people, places, and things that have shaped Minnesota, along with gear from her historic expeditions.

"I had so many dreams as a young girl. I always wanted to go where no one had ever been."

BOARD OF DIRECTORS

LaCora Bradford Kesti serves as Vice President of Community Impact at the Women's Foundation of Minnesota. Hailing from Minneapolis, LaCora has over two decades of experience living, volunteering, and working in the Twin Cities metro area. She is a Northside Community Member in the Camden-Lind Bohanon neighborhood. She graduated from the College of St. Scholastica and completed two years of AmeriCorps, fulfilling over 3,400 service hours for the betterment of her community.

Last June, she accepted a role on the Ann Bancroft Foundation Board of Directors. She also serves as Board Co-Chair for Hope Community, where she has served for five years.

"One dream I had as a child was that the street lights would never come on at night. I wanted the sun to stay just low enough to play outside all day."





AALIYAH MURRAY

DREAMMAKER HONOREE

Aaliyah Murray is an 18-year-old social justice activist. She is an advocate for youth civic engagement, Black Lives Matter, gun violence and police brutality prevention, and restorative care for youth. Aaliyah was only 14 years old when she started Global Teen Activists, an intersectional youth-led organization committed to eradicating systemic injustices in schools and communities through advocacy and action. She noticed racist incidents in schools where her peers would not get justice and decided enough was enough. She strove to create a space where youth didn't have to ask for a seat at the table; it was already there for them.





OLUWATOMINI OLA

DREAMMAKER HONOREE

Oluwatomini Ola began her advocacy journey with the Ann Bancroft Foundation through the Dare to Dream grant. She utilized the grant to empower African immigrant girls through mental health literacy. She then received the Women's Foundation of Minnesota Innovators Program grant to continue her work in promoting mental health literacy and empowerment among girls and women. Simultaneously, she pursued academic excellence, earning a Bachelor's of Science in Psychology and nearing completion of a Master's degree in Public Health with a focus on Global Health.

Oluwatomini's relentless dedication extends beyond academia as she lends her voice to the Minnesota Young Women's Cabinet, championing women's rights and equality. Her tireless efforts embody a profound commitment to empowering individuals, especially young girls and women, through education and advocacy. In addition to her remarkable journey thus far, Oluwatomini harbors ambitious aspirations for the future. With a steadfast dedication to advancing community health, she envisions pursuing a Ph.D. in Community Health.



CLOIE STEVENS

DREAMMAKER HONOREE

Cloie Stevens is a young, innovative businesswoman. Her entrepreneurial journey started at 14 years old, when she decided to open a Cottage Food Licensed bakery at the farmer's market in her hometown of Marshall, Minnesota. As her customer base grew, so did Cloie's love for the business world. Shortly after her own business started, Cloie collaborated with a fellow youth business owner to create a youth-only vendor market within their community, coined the KindlMarkt. Since its inception, the KindlMarkt has tripled in size and now features upwards of 30 vendors as well as being a regionally supported event. Cloie was actively involved in many organizations throughout high school, including the CEO Program, where she served as the Chief Operating Officer of the class business and was tasked with creating a new business. Through an investment from the CEO Program and the generous help of an Ann Bancroft Foundation grant, Cloie was able to print and publish her own cookbook *Gather: The Foods That Made Me*. Currently, Cloie is a full-time student at the University of South Dakota, pursuing a business degree with the hopes of continuing to inspire and support other youth entrepreneurs.



NAT VUONG

ANNUAL EVENT ILLUSTRATOR

Nat Vuong is a 16-year-old artist from Coon Rapids, Minnesota. They are a multi-media artist, working with drawing, sculpture, digital art, and more. In Fall 2023, Nat received a grant from the Ann Bancroft Foundation to purchase materials to create new art pieces, some of which they intend to sell at upcoming art fairs. They were previously featured in the SEA Us Write & Design art exhibition with the Hmong Girls' Circle, where they created the sculpture "Fibrous Fantasm." They dream of one day building a successful art business and being featured as a solo exhibitionist in art galleries.

Inspired by our theme of "The Gift of Girlhood," Nat created the cover page illustration "Girls in a Field." Two girls lie down in a luscious grass field looking at ants going in and out of an ant hill. They laugh and talk as they watch the ants feast. A few other bugs skitter about in the grass; some flowers can be seen amongst the grass. Dragonflies, which symbolize change, adaptation, and transformation, are also present.





DR. GIGI CHAWLA

EVENT CO-CHAIR

Gigi Chawla, MD, MHA, pediatrician, is Children's Minnesota's Chief of General Pediatrics. She received her medical degree and business degree from the University of Minnesota. In her professional role, she oversees primary care, rehabilitation services, and mental, developmental, and behavioral health, including developing an inpatient mental health pediatric unit and partial hospitalization mental health programs. The media often calls upon her for her pediatric expertise, and she is a regular contributor to the Minnesota Parent column and WCCO's segment "Ask the Pediatrician." Her clinical areas of interest are the outpatient and inpatient care of complex special needs patients, premature infants, and ventilator-dependent children. Dr. Chawla is also instrumental in advancing the organization's forward-looking efforts around community engagement.

"At a young age, I had a preconceived notion of what my path in life was going to be, and was often disappointed that it played out differently than I had expected. What I didn't realize at the time was that those twists and turns on the path were important and led to better things than I had ever anticipated in the first place."

Currently, Jamie consults on the narrative and design strategies at Margaret A. Cargill Philanthropies. Jamie has been identified as a “40 Under 40” by the Minneapolis/St. Paul Business Journal and as a “100 People to Know” by the Twin Cities Business Magazine. Nationally, Jamie was recognized in the Huffington Post as one of four millennial leaders, “doing important work to move us toward a more just and equitable society.” Jamie lives in Minneapolis and is a mother of three young daughters who teach her every day about the power of joy. She is passionate about multigenerational households, living a healthy life with rheumatoid arthritis, and motherhood.

LESSON TO MY YOUNGER SELF

“I’d go back and tell myself, ‘play more.’ I always felt a tension between wanting to escape into my imagination and play with what I felt were my responsibilities to overachieve. We grow up too fast and childhood is where we learn how to imagine, play, and find joy.”

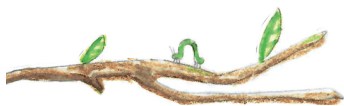

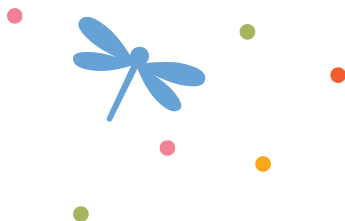

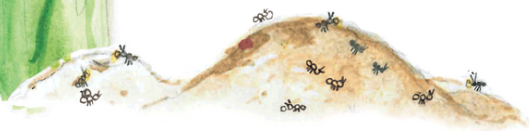
